**Limited Review Report on the Unaudited Standalone Financial Results for the quarter ended on June 30, 2018 pursuant to the Regulation 33 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015.**

To the Board of Directors of

**Ecoplast Ltd.**

1. We have reviewed the accompanying statement of Unaudited Standalone Financial Results (“the Statement”) of **Ecoplast Ltd.** (“the Company”) for the quarter ended 30<sup>th</sup> June, 2018, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 read with Circular No.CIR/CFD/FAC/62/2016 dated July 5, 2016.
2.
